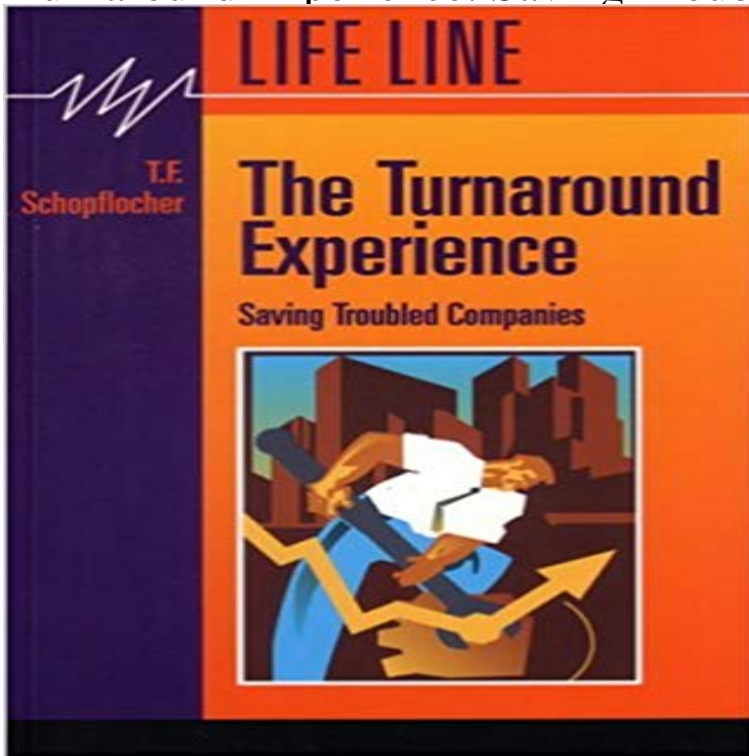


## Turnaround Experience: Saving Troubled Companies
